Discussion of Parks & Recreation Planning for 2022-2023

Village Administrator addressed the Commission with a brief background of the changes in both the leadership of the Village and with the Commission. Many if not all the Commission programs were put on hold in 2020. In 2021, the Commission restarted a couple of programs including Concert in the Park and Fall Festival. Administrator Lobaito explained the Commission is free to consider new programs, although the number and type of programs will be limited by time and money.

There was discussion about the 2022 events to be held at Eton Park. The Summer Concerts will be held on June 11, 2022; July 9, 2022; August 13, 2022; and September 10, 2022. There will be a 9-11 Tribute at the September 10, 2022 Concert. The Fall Festival will be held Sunday, October 9, 2022, from 1:00 pm to 4:00 pm with the rain date October 16, 2022.

The Commission members will coordinate the music for the Summer Concerts.

The possibility of a Holiday Tree lighting at Eton Park was discussed. Administrator Lobaito referred the Commission to a map in their meeting packet, highlighting the various parks and open space in the Village. The possibility of a consultant was discussed, the objective being the creation of a long-term plan for the maximum usage of the Village parks.
