President Sweet McDonnell informed everyone that Commonwealth Edison presented at the meeting and said that they are seeking a rate increase due to fuel costs, inflation, and anti-terrorism improvements at their facilities. President Sweet McDonnell stated that due to the Aggregation Program the Village signed a three-year contact and locked in the price of electricity. If there is an increase in electricity cost North Barrington residents cost of electricity will remain the same. However, the cost to deliver the electricity to homes could go up in price. The Mayor for the City of Chicago presented and was appealing to the mayors to support a new Business Incentive District (BID) program to benefit businesses.
