Some of the adjustments to the 2025 event include placing banners on the tents, a larger hot box, a larger donut order, more garbage totes, more small and medium sized t-shirts, and possibly offering soft drinks and corn on the cob. The Commission would like to look at alternatives to Patch 22 for the petting zoo and hayride.

The date of the 2025 Festival will be determined once the date of Homecoming 2025 is established by Barrington High School.

The commission will begin a Parks and Recreation Commission volunteer recruitment program. Dwight Bennett will email the members of his neighborhood homeowners association to encourage volunteer participation. The possibility of sub-committees was discussed. The number of volunteers at the Fall Festival was adequate. The Commission would like to continue utilizing the Village website, quarterly newsletters, E-blasts and Facebook to promote resident participation in the Village events and commissions. Many resident attendees expressed their positive impression of the new Leonard Path walking path, a rendering of which was displayed at the Fall Festival.

Discussion of 2025 Dates

The Commission discussed the 2025 dates for the Parks and Recreation Commission events. The dates are tentative and could change if modifications are made to the events. David Lauffer would like to have a forecasted 2025 agenda for the entire year. He has filled in some of the months which can be viewed in the Microsoft Planner App. The Commission plans to have a 2025 Holiday Tree Lighting event which would include Santa and hot chocolate. The Commission meeting dates could possibly be adjusted based upon recruitment of new members and their availability.
