Fall Festival Review/Recap

The Commission agreed the 2023 Fall Festival was a success and well attended. The weather was warmer than expected. There was extensive discussion and suggestions for the Fall Festival scheduled to be held on October 6, 2024.

- The Commission would like to invite the Lake Zurich Fire Protection District to bring a fire truck. A first aid kit and defibrillator would also be on site.
- Order portable toilets with hand sanitizers, confirm with the petting zoo if they supply hand sanitizers, and order two hand washing stations.
- It was agreed that the weather forecast should be monitored the week prior to the event to have the proper amounts of water, coffee, and cider.
- The Commission discussed additional features for 2024, such as a harmonica player, caricature artist, T-shirts, and gift bags for volunteers. An additional small tent for the magician was suggested. The Village President expressed concern about the additional costs that would add to the event, and mentioned there were a significant number of attendees that were not Village of North Barrington residents.
- The Commission agreed that an improved executed plan for event volunteers was essential, as well as a contingency plan in the event of bad weather. The report from the Scouts was positive.
- The amount of food was sufficient. Ideally the donuts would be delivered warm. The possibility of renting a popcorn machine in 2024 was suggested.
