Village Administrator John Lobaito stated he had a list of consultants and comprehensive plans used by other municipalities for their park projects.

Survey of Park and Village Pathways for May 2023; Dog Park, Pickle Ball, Volleyball Pit

Village Administrator John Lobaito stated the timbers in Eton Park have been replaced. There are plans to power wash the basketball court, Eton Park benches, playground, and pavilion. Specialized mulch will be ordered for the playground. The park boardwalk is in adequate condition. There are 30 parcels of property owned by the Village, some of which could be used in a conceptual Village parks expansion project. A survey of residents about their park use is still planned. Ela Township will erect volleyball nets at Eton Park. A new TREK boardwalk for Leonard Park was discussed. It is currently too wet and muddy to traverse and evaluate.

Community Survey Discussion

The Commission discussed sending the Village residents a survey to obtain resident input about their use of the Village parks and items they would like to see addressed.
