Chapter 1

USE OF PARKS AND PUBLIC PROPERTY

6-1-1: PROHIBITED ACTS:

6-1-1: PROHIBITED ACTS:

It shall be unlawful for any person, firm or corporation, or civic or social group using any Village park or any Village right of way or any other Village property either to perform or permit to be performed any of the following acts:

A. Damage To Property:

- 1 . Willfully mark, deface, disfigure, injure, tamper with or displace or remove any tables, benches, fireplaces, railings, paving or paving material, signs, fences, playground or exercising equipment or any other Village property or utilities, whether temporary or permanent whatsoever, either real or personal. (1 977 Code S 8-7-12)
2. Cut, break, or in any way deface any tree, shrub, plant, turf, or any of the buildings, fences or bridges, lamps or posts, or other structures or property within any Village park or on any Village right of way or on any other Village property. (1 977 Code S 8-7-9)

B. Pollution Of Water:

- 1 . Throw, discharge or otherwise place or cause to be placed in the water of any pond, lake, stream, marsh, or natural impoundment area or drainage ditch in or adjacent to any Village park, right of way or other Village property or in any tributary or in any drain flowing into such water, or in, on or upon any Village park, right of way or other Village property, any matter or things, liquid or solid, which will or may result in the pollution of said water or the interference with drainage.
2. Discharge or drain any stormwater into the water of any pond, lake, stream, marsh, or natural impoundment area or drainage ditch in, on or adjacent to any Village park, right of way or other Village property or any tributary or drain flowing into such water, or in, on or upon any Village park, right of way or other Village property other than in the course of its natural drainage. (1 977 Code S 8-7-12)

C. Dumping Garbage, Refuse And Sewage: Deposit, dump, throw, or place any rubbish, including tree, shrub or grass trimmings, or litter or junk of any kind, or discharge or drain any solid or liquid, other than stormwaters in the general course of their natural drainage, in or upon any part of any Village park or upon any Village right of way or in or upon any other Village property. Paper, garbage, or refuse matter shall not be so deposited except in receptacles provided for that purpose. (1 977 Code S 8-7-7)

- D. Liquor; Glass Containers: Bring within, sell, give away or drink any intoxicating liquors in any Village park or on any Village right of way or on any other Village property; provided, however, that drinking of alcoholic liquor by adults shall be permitted in a Village park during the hours when such park is being utilized for a Village sponsored event and an event sanctioned by the Village if the liquor control commissioner has specifically authorized the drinking of such alcoholic liquor at such event. No glass bottles or containers shall be allowed in any such locations referred to above. (Ord. 1 143, 5-28-2008)
- E. Advertisements: Display any placard or advertisement of any kind in any Village park, nor distribute, cast, throw or place any handbill, pamphlet, circular, advertisement, or notice of any kind, nor post, stencil or otherwise affix any notice or bills, advertisements or other papers upon any structure or thing in any Village park or on any Village right of way or on any other Village property. (1 977 Code S 8-7-8)
- F. Disturbing The Peace; Profanity: Disturb the peace, or use any profane, obscene or blasphemous language.
- G. Endangering Others: Endanger the safety of any person by any conduct or act.
- H. Interfering With Others: Prevent or interfere with any person lawfully using any Village park or any Village right of way or other Village property.
- I. Assault, Battery , Fighting: Commit any assault, battery or engage in fighting. (1 977 Code S 8-7-12)
- J. Presence In Restricted Areas: Enter upon any portion of any Village park or other Village property where persons are prohibited from going by direction of the Superintendent of Parks as indicated by a posted sign or notice or by a verbal order directed to such person or persons. (1 977 Code S 8-74)
- K. Violation Of Rules And Regulations: Violate any rule for the use of any Village park, right of way or any other Village property made or approved by the corporate authorities. (1 977 Code S 8-7-12; amd 2004 Code)

6-1-2: RESTRICTED ACTS AND CONDITIONS:

- A. Vehicles: No person, other than authorized personnel, shall bring or use any vehicle, including, but not limited to, motorcycles, motorbikes, minibikes, or mopeds, upon any portion of any Village property except as designated by the Superintendent of Parks. This subsection shall not apply to Village rights of way. (1977 Code S 8-7-1)
- B. Sales Of Merchandise: No person shall offer or exchange for sale any article or thing, or do any hawking, peddling, or soliciting, or buy or offer to buy any article or thing, or take up any collection, or solicit to receive contributions of money or anything of value in any Village park or on any Village right of way or on any other Village property, except in compliance with title 3, chapter 2 of this code and only when authority to do so has been granted by the Village Board of Trustees. (1 977 Code S 8-7-2)

C. Public Meetings Or Assemblies: No person shall call or hold any public meeting or assembly, or give any concert or public entertainment of any kind in any Village park or on any Village right of way or on any other Village property without the express consent of the Village Board of Trustees. (1 977 Code S 8-7-3)

D. Fires: No person shall light or make use of any fire in any Village park or on any Village right of way or road or on any other Village property, except portable barbecue equipment or except in such portions thereof and at such locations as may be indicated by the Superintendent of Parks for such purposes and then only under such regulations as are prescribed by him. (1 977 Code S 8-7-5)

E. Animals: It shall be unlawful to bring any animal into any Village park or onto any other Village property without the expressed consent of the Park Superintendent. (1 977 Code S 8-7-12)

6-1-3: PERMIT TO USE VILLAGE PARKS:

A. Permit Required: All persons using any Village park shall be required to have a permit which will be issued by the Village Clerk.

B. Registration Of Family Members; Vehicle Sticker Required: Each family member shall be registered, and each car shall display a North Barrington vehicle sticker.

C. Representative Of Civil And Social Groups: A permit will be issued to the leader of each civic or social group.

D. Permit Fees:

E. Term Of Permit: The period for which the permit is valid shall be the same as that of the current vehicle sticker. (1 977 Code S 8-7-13)

6-1-4: HOURS OF OPERATION OF VILLAGE PARKS:

All parks owned and controlled by the Village shall be open daily to the public from sunrise to sunset. It shall be unlawful for any person, other than authorized personnel conducting official business, to occupy or be present in said parks during any hours which the parks are not open to the public. Any section or part of parks may be declared closed to the public by the Superintendent of Parks at any time, and for any interval of time, either temporarily, or at a regularly stated time. (1 977 Code S 8-7-10; amd. 2004 Code)

6-1-5: CLEANUP OF AREAS USED:

Each person, firm or corporation, or civic or social group using any Village park or other Village property and grounds shall clean up all debris, extinguish all fires when such are permitted and leave the premises in good order and in a neat, sanitary condition. (1 977 Code S 8-7-1 1)

6-1-6: VIOLATION; PENALTIES:

Any person, firm or corporation, or civic or social group who violates, disobeys, omits, neglects or refuses to comply with, or who resists the enforcement of any of the provisions of this chapter shall be guilty of a misdemeanor and shall, upon conviction, be fined a minimum of fifty dollars (\$50.00) but not to exceed seven hundred fifty dollars (\$750.00) for each offense; provided, however, the minimum fine for any violation of subsection , A2, B1 or C and section 6^m of this chapter shall be two hundred dollars (\$200.00).
