DRIVEWAY SUBMITTAL REQUIREMENTS

- ____ 1. Building Permit Application
- ____ 2. \$50.00 Application Filing Fee (cash or check made payable to Village of North Barrington.)
- ____ 3. Two (2) copies of Plat of Survey depicting existing driveway.
- ____ 4. Two (2) copies of Proposal/Contract from paving contractor describing project scope and specifications. The proposal/contract from the paving contractor must separate the cost of the driveway pavement and the culvert replacement cost.

DRIVEWAY SPECIFICATIONS

- 1. Asphalt (See Exhibit A)
- 2. Concrete (See exhibit B)
- 3. Brick Pavers (See Exhibit C)

Following receipt of a permit application, Ela Township will perform an inspection to determine if culvert replacement is necessary.

CULVERT REPLACEMENT SPECIFICATIONS (VILLAGE CODE SECTION 9-1-12)

Culverts located within the right-of-way of public streets, whether under driveways or under the streets themselves, as well as culverts under driveways located on private property, shall be constructed under the supervision of the Village Engineer and shall be constructed of one of the following materials and shall have the following specifications:

- A. Reinforced concrete; or
- B. Corrugated polyethylene with smooth interior; or
- C. Polyvinyl chloride (Schedule 26)

All flared end sections, fittings and specials shall match the pipe in all respects. It is preferred that all portions of such pipe which are visible after installation has been completed be a neutral color.

All pipe, except reinforced concrete, shall have at least twelve inches (12") of cover from the top of the pipe to the bottom of the hard surface pavement, except where lesser cover is authorized by the Village Engineer.

CULVERT REPLACEMENT COST SHARING PROGRAM (ORD. NO. 2022-01)

A private property owner may request financial assistance from the Village of North Barrington for the replacement of the existing culvert pursuant to the following conditions:

1. Qualified Work: The Village will reimburse up to 50% of the total cost of the lowest two (2) quotes for the culvert replacement, or \$2500.00, whichever is less.
2. The Village will reimburse the property owner upon proof of payment in full to the contractor.
3. The Village reserves the right to not reimburse property owners if it determines that there are no available funds in the budget to provide financial assistance.

I/We will conform to the regulations set forth in the Village Code and Zoning Ordinance of the Village of North Barrington. I/We will also agree that all work performed under said permit will be in accordance with the documents which accompany this application, except for such changes as may be directed in the permit issuance. I/We further state that I/We make this application in order to induce the Department of Building & Zoning of the Village of North Barrington to issue the official permit for the uses stated herein.
